NEW STREET LIGHTS

New street lights will be installed in Arrowhead in 2024. The present lighting is deteriorating with age. It has different poles and different intensities of lights. The lights shine directly down and not outward. The new lights are a much nicer design and will shine outward and down providing more light throughout the community. They will also greatly increase the look and beauty of the community. The new lights will be 12 feet in height, black in color with frosted lenses and mounted on a three-inch concrete base in the areas of the existing lights.

TRASH AND RECYCLING CONTAINERS

The community looks better when trash and recycling containers are in their storage location, not on the streets. Place them at the curb the night before after 7 p.m. and return them by Monday evening.

Rules and Regulations.

They are periodically revised to address new issues and to provide more options for homeowners while keeping the community beautiful. Regulation

Trash Pick-up Days 2024

Trash and recycling are picked up by the township each Monday with the following exceptions which are township holidays: MLK day (1/15/24), Presidents' Day (2/19/24), Memorial Day (5/27/24), Labor Day (9/2/24) and Columbus Day (10/14/24). The alternate pickup day is Wednesday. All trash and recycling must be in the containers.

Additional Trash Pickup on Wednesdays is available for a fee (call the township to arrange). **Large Item (bulk) Pickup** can be arranged with the township for a fee (216-643-1600 Ext 0). **Yard Waste** will be picked up on Thursdays until the end of November.

Pet Waste

Please pick up after your pet to keep our community beautiful. There are two dog waste stations in the community with plastic waste bags and a waste disposal container. Both are on Arrowhead Trail. One is near the playground and the other is at the open area across from Navajo Path.



DUMPING IN WOODED AREAS OF COMMUNITY

Please do not dispose of things in the wooded areas of our community, such as grass clippings, dead plants or bushes, food waste or any other items, it greatly detracts from the beauty of the community. Place grass clippings in your yard waste container. The township will compost them.







HOLIDAY DECORATIONS

Holiday decorations are permitted to be installed 30 days prior to a holiday and removed 21 days following the holiday. Inflatable decorations are permitted during holidays. They shall not exceed 8 feet in height and not obstruct neighbor's property.



Christmas Tree Collections

Christmas trees will be collected after the holiday on the following trash days: Wednesday 1/3 (Monday – holiday), Monday 1/8 and Wednesday 1/17 (Monday – holiday). Place trees at the curb with all decorations removed and NOT in a plastic bag.



SNOW REMOVAL

Snow is removed from the community when more than 2 inches is expected. The order of snow clearing is: streets first, followed by common walkways, visitor parking spots, contemporary house driveways and homeowner parking spots last. After streets and visitor parking spots are cleared, move your cars to the visitor parking spots or along Arrowhead Trail. This will open up the homeowner parking spots to be cleared. If you see the small snow plow vehicle on your street, let your neighbors know that they should move their vehicles to enable parking spots to be cleared. If two inches or less of snow is received, residents are responsible to remove snow and ice from the walkway of their house and the common sidewalk in front and on the side of their house. If salt is used to melt ice, use calcium chloride, not sodium chloride, it causes damage to concrete.



Fire Protection for Arrowhead

The Fort Washington Fire Company provides fire protection for our community. They are staffed by volunteers. Donations enable them to purchase new equipment and maintain existing equipment.
