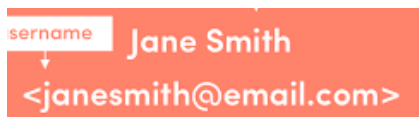

## Trash Collection

### Collection Days - Fall 2025 & Spring 2026

Trash and recycling are collected by the township each Monday except for the following which are township holidays:

2025 - Labor Day (9/1/25), Columbus Day (10/13/25). 2026 - MLK day (1/19/26), Presidents' Day (2/16/26) and Memorial Day (5/25/26). The alternate collection day is Wednesday. All trash and recycling must be in the containers.



**Additional Trash Collection** on Wednesdays is available for a fee. Call the township to arranged - 215-643-1600.



**Large Item (bulk) Pickup** can be arranged with the township for a fee – 215-643-1600.



**Yard Waste** is picked up on Thursdays until the end of November. Do not use a township trash or recycling container for yard waste. Use a township yard waste container (green in color), paper yard waste bags or your own containers. If you want a township yard waste container, call the township and one will be delivered – 215-643-1600.



**Collection of Cardboard that will not fit in the Recycling Container.** Bulk cardboard collection is on Wednesdays. The collection is free, but must be scheduled before 2 pm on the Tuesday before (complete request form at [upperdublin.net/bulk](http://upperdublin.net/bulk)). The cardboard must be flattened, tied and placed at the curb or end of your parking spot.



### Christmas Tree Collections

Christmas trees will be collected after the holiday on the following three days: Monday 1/5/26, Monday 1/12/26 and Wednesday 1/21/26 (Monday 1/19/26 is a holiday). Place trees at the curb or end of your parking spot

with all decorations removed and not in a plastic bag.



### Smoking Marijuana in Community

Residents have reported to the Arrowhead Board of Directors that there is the smell of Marijuana smoke in the air on a regular basis. It is illegal to smoke Cannabis (Marijuana) in Pennsylvania, except for registered persons in an approved medical health Marijuana program. The U. S. Surgeon General and the Center for Disease Control have reported that second hand smoke is harmful to persons who do not smoke. Cigarette smoke spreads freely ending up in our homes, on our decks and around our patios. Arrowhead residents live in close quarters and it impacts everyone when smoke drifts from one property to another. If you smoke marijuana, please be mindful of your neighbors and smoke it inside your house or outside the community.



### Dog Waste Stations –Volunteers Needed

Help is needed at the dog waste station near Tennis Avenue. Volunteers are needed to help with replenishing the bags and removing the waste, especially removing the waste. Dog waste should be removed twice a week; Wednesdays and Sundays are good days to remove it since trash day is on Monday. Replacement bags are in the dog station. Please consider helping. **We currently have one person removing the waste. If that person stops, the Association will be forced to remove the dog station and have only the one near the Tot Lot.**



### **Holiday Decorations**

Holiday decorations are permitted to be installed 30 days prior to a holiday and removed 21 days following the holiday. Inflatable decorations are permitted during holidays. They shall not exceed 8 feet in height and not obstruct neighbor's property.

### **SNOW REMOVAL**

Snow is removed from the community when more than 2 inches is expected. The order of snow clearing is: streets first, followed by common walkways, visitor parking spots, contemporary home driveways and homeowner parking spots last. After streets and visitor parking spots are cleared, move your cars to the visitor parking spots or along Arrowhead Trail. This will open up the homeowner parking spots to be cleared. If you see the small snow plow vehicle on your street, let your neighbors know that they should move their vehicles. If two inches or less of snow is received, residents are responsible to remove snow and ice from the walkway of their house and the common sidewalk in front and on the side of their house. If salt is used to melt ice, use calcium chloride, not sodium chloride which causes damage to concrete.



### **Speeding in Arrowhead**

Some residents are still driving too fast in the community. 25 mph on Arrowhead Trail and 15 mph on Arrowhead streets. Regardless of your speed, watch for people walking, children playing and deer grazing.
